Artisans:
It is a proven fact that the exhibitors with the most attractive booths are the "TOP SELLERS" at our shows!
Per Lease Agreement #2 you must have an Attractive Decorated Booth!

Our artisans put many hours into building an attractive booth at our shows! This makes the shows very appealing and professional. Out of fairness to all vendors who put a lot of time and effort into building a beautiful booth, we ask you to please adhere to these rules!!!

Booths must be 6-8 feet tall and solid so you can't see back of neighbor's booth!
Examples...

- Backdrop can be made of solid walls or shelving
- Pipe and drape
- Lattice or wired grids with cloth on back so as not to be seen through to back of booth.

We prefer you not to use pop-ups!
However, if need be you must remove canopy. All poles must be covered and decorated with (fabric, garland, etc.) Please don't use the plastic canvas typical of pop-ups, replace with fabric or drapes.

Booths without any kind of backdrop will NEED to rent pipe and drapes.
